

Terms and Conditions

- Program:** This program deals with the stabilization of streambanks by means of armoring the eroding banks with rock rip-rap or other stabilizing material, and the establishment of a 10 meter buffered riparian area where trees and/or other vegetation is planted to further stabilize the affected area.
- Objective:** This program provides assistance to stabilize eroding streambanks in the IMWD area. By armoring these areas with rock-rip-rap or other material, land and infrastructure is protected from further erosion and preventing nutrient and sediment loading concerns downstream.
- Eligibility:** The channel must be a natural watercourse with banks that require stabilization to prevent further channel erosion and protect infrastructure which can be stabilized through the placement of rip-rap materials and/or vegetation.
- Assistance:** Funding for approved Streambank Stabilization Projects will be cost-shared in the ratio of 15% applicant, and 85% IMWD in Priority 1 sites (threatening yard/infrastructure) and 40% applicant 60% IMWD in Priority 2 sites. Applicants contribution may be accepted in kind on a case to case basis as well extenuating circumstances may be 100% externally funded. Approved applicants will be required to make a down payment of 50% of the estimated contribution prior to the project being started.

General Information:

- Land must be within the Inter-Mountain Watershed District and the following subdistricts Fishing/Fork/Mossey, Garland/Point, Lower Valley/Mink Creek, Pine/Sclater/Duck, Upper Valley, Wilson River and Vermillion River.
- All projects are to be approved by the IMWD prior to construction and are subject to available funding.
- All necessary approvals will need to be in place prior to construction.
- The district shall determine application priorities in consultation with Sub-district, Board and Staff.
- Engineering and technical service for project design, construction and maintenance will be subject to the availability of funding and/or staff. The IMWD reserves the right to establish priorities for providing such services and assistance.
- Other remedial actions, aside from, or in addition to streambank armoring, may include other erosion control efforts, construction of pool-and-riffle structures, drop structures, and/or any necessary land treatment, including the restoration of a treed riparian area, so as to minimize the risk of further on-site and/or downstream problems.
- IMWD reserves the right for reasonable access to the project site for inspection and to promote the program.
- Final landscaping of project site to be completed by landowner.
