Terms and Conditions

Objective:

• As IMWD is seeing higher peak flows in its waterways, the goal of this program is to create short-term water retention areas in order to reduce downstream water flows and the subsequent erosion and infrastructure damage. Projects could involve engineered structures or simply the re-establishment of a historical wetland.

Eligibility and Conditions:

- Land must be within the Inter-Mountain Watershed District.
- Applicant must be in good standing with the watershed district.
- Signed consent forms from any upstream or downstream landowners affected by the project is required before construction.

Assistance:

• Water retention projects will be cost shared on an case-by case basis. IMWD reserves the right to determine the percentage of landowner contribution required on retention projects. External funding may cover 100% of costs if IMWD determines there is no direct benefit to the landowner. Applicants contribution may be contributed in kind as per the discression of IMWD.

General Information:

- All projects are to be approved by the IMWD prior to construction and are subject to available funding.
- The District shall determine application priority in consultation with Sub-district, Board and Staff.
- All necessary approvals will need to be in place prior to construction.
- Engineering and technical service and financial assistance for project design, construction and repairs will be subject to the availability of funding and/or staff. The IMWD reserves the right to establish priorities for providing such services and assistance.
- IMWD shall inspect the retention area annually for up to five years, and monitoring will continue for the duration of the agreement with the landowner's assistance. Any repairs will be subject to the same cost-share as the original project.
- IMWD reserves the right for reasonable access to the project site for inspection and to promote the program.
- Indemnify and save harmless the Inter-Mountain Watershed District, their agents, engineers, servants and /or employees from any liability that may result from this project.
